

# TRAVIS COUNTY 4-H

## 2014 Turkey Order

1. The attached order form and payment for your turkey poults must be returned to the Travis County 4-H office on or before July 3, 2013.
2. The poults cost \$3.50 each, and a maximum of 75 poults per family unit may be ordered. "Merging families", where two or more groups of children with different last names reside in the same household, will be considered as single family unit. Your minimum order per family must be 10 birds. Our county 4-H total order must be in multiples of 25. If our county order does not total to a multiple of 25, then we will contact each family to request adjustments to fit this "multiples" requirement.
3. Make one check payable to "Travis 4-H".
4. If a family has one member who plans to show under 4-H and another who plans to show under FFA, you must place your order with only ONE ORGANIZATION. Individual members will still be eligible to exhibit under their selected organization. Make sure to include all family members (\*4-H & \*FFA) on the order form.
5. These poults will be eligible for the 2014 Houston Livestock Show (one turkey entry), the 2014 San Antonio Livestock Exposition (may enter a hen and a tom), the 2014 Travis County Youth Show (may enter one tom and one hen), and the 2014 Star of Texas Fair & Rodeo (one turkey entry). You will be required to fill out entry forms this fall for each show that you chose to show in.
6. The poults will be commercial strain Broad Breasted White. They will be "straight-run" poults, which means that *they will not be sexed*.
7. Poults will be hatched at a TBD date (plan for late October). A CEA (or designated representative) will pick up the poults on the designated date. The birds will be delivered to the Extension Office in Travis County for pick up.
8. Order Form: Make sure you include names of all children who will be eligible just in case they wish to show at a later date. (4-H exhibitors must be 8 and in the third grade by August 31, 2013); use the names that you plan to use on your entry card(s); if your order includes 4-H and FFA family members, please indicate which individuals are 4-H and which are FFA; include your payment and return before the deadline.
9. Check with your club manager and watch the Travis 4-H blog for entry due dates. If you are not registered in the 4-H Connect System by the hatch date, you will not be allowed to pick up your poults!!!
