I HEREBY MAKE APPLICATION FOR ENTRY/EXHIBITION IN THE STAR OF TEXAS FAIR AND RODEO ("RODEO AUSTIN"). AS A CONDITION OF SUCH ENTRY, I HEREBY CERTIFY THAT I HAVE READ AND AM FAMILIAR WITH THE RULES AND REGULATIONS OF RODEO AUSTIN, INCLUDING THE RULES AND REGULATIONS CONTAINED IN THE CURRENT RODEO AUSTIN PREMIUM BOOK (THE "REGULATIONS"), AND THAT MY ENTRY/EXHIBIT, WHETHER ONE OR MORE, IS OWNED AND HAS BEEN FED, FITTED AND EXHIBITED IN ACCORDANCE WITH THE REGULATIONS. I AGREE THAT SHOULD THIS CERTIFICATION PROVE FALSE, I CAN BE DISQUALIFIED FROM FURTHER PARTICIPATION IN ALL ACTIVITIES OF RODEO AUSTIN AND WILL FORFEIT ALL PRIZES, PREMIUMS, PRIVILEGES, AND RIGHTS OF AN EXHIBITOR, INCLUDING THE PRIVILEGE OF SELLING MY ENTRY/EXHIBIT OR ANY OTHER ENTRY/EXHIBIT IN THE RODEO AUSTIN AUCTION. SHOULD THIS CERTIFICATE PROVE FALSE AFTER THE ENTRY/EXHIBIT OR ANY OTHER ENTRY/EXHIBIT HAS BEEN SOLD BY ME IN THE RODEO AUSTIN AUCTION, I AGREE THAT I SHALL FORFEIT THAT PORTION OF THE PRICE BID AT THE AUCTION FOR THE ENTRY/EXHIBIT.

WE, THE EXHIBITOR AND PARENT/GUARDIAN HAVE NOT ADMINISTERED TO ANY EXHIBIT/ENTRY ENTERED BY EXHIBITOR, AND TO THE BEST OF OUR KNOWLEDGE, THE ENTRY HAS NOT RECEIVED, ANY SUBSTANCE NOT APPROVED BY THE U.S. FOOD AND DRUG ADMINISTRATION (FDA) AND/OR THE U.S. DEPARTMENT OF AGRICULTURE (USDA) FOR CONSUMPTION ANIMALS. WE FURTHER CERTIFY THAT NO EXHIBIT/ENTRY UNDER OUR CONTROL WILL BE WITHIN ANY WITHDRAWAL TIME RELATIVE TO THE ADMINISTRATION OF ANY DRUG, CHEMICAL OR FEED ADDITIVE APPROVED BY THE FDA AND/OR USDA AT ANY TIME AFTER ARRIVAL OF THE ENTRY/EXHIBIT ON THE GROUNDS.

VETERINARIANS/TREATMENT/MEDICATION: WE AGREE TO COMPLY WITH THE FOLLOWING FOR ANIMALS REQUIRING EMERGENCY TREATMENT WHILE AN ANIMAL IS AT RODEO AUSTIN AND HEREBY RELEASE RODEO AUSTIN FROM ANY AND ALL DAMAGES WHICH MIGHT ARISE OUT OF SUCH TREATMENT OR RELATED ACTION:

(A) RODEO AUSTIN SHOW VETERINARIAN MUST APPROVE, IN ADVANCE, ANY TREATMENT OF AN ANIMAL, REQUIRING DRUGS, CHEMICALS OR FEED ADDITIVES WHILE THE ANIMAL IS AT RODEO AUSTIN. ALL TREATMENT COSTS ARE THE RESPONSIBILITY OF THE EXHIBITOR.

(B) WE ALSO AUTHORIZE RODEO AUSTIN TO OBTAIN SAMPLES FROM ANY EXHIBIT FOR DRUG TESTING AND AGREE TO THE FOLLOWING DISQUALIFICATION POLICY OF RODEO AUSTIN:

DISQUALIFICATION POLICY

IF AN ANIMAL TESTS POSITIVE FOR DRUGS, CHEMICALS OR FEED ADDITIVES AS DESCRIBED ABOVE AND/OR THE CARCASS IS CONDEMNED AT SLAUGHTER, RODEO AUSTIN RESERVES THE RIGHT TO DISQUALIFY ANY ANIMAL. IF ANY ANIMAL IS DISQUALIFIED, RODEO AUSTIN MAY REQUIRE THE EXHIBITOR TO FORFEIT ALL AUCTION SALE AND/OR PREMIUM MONEY AND FORFEIT ALL RIGHTS AND PRIVILEGES TO EXHIBIT AT RODEO AUSTIN IN THE FUTURE. THE CLASS PLACING WILL NOT CHANGE IF AN ANIMAL IS DISQUALIFIED. AN EXHIBITOR OF AN ANIMAL PRODUCING A POSITIVE SAMPLE OF A SUBSTANCE NOT APPROVED FOR CONSUMPTIVE ANIMALS BY FEDERAL OR STATE LAW WILL BE REPORTED TO THE APPROPRIATE LAW ENFORCEMENT OFFICIAL FOR POSSIBLE CRIMINAL PROSECUTION.

RODEO AUSTIN IS THE FINAL JUDGE OF COMPLIANCE WITH RODEO AUSTIN REGULATIONS AND POLICIES.

General Instructions

Section references are to the Internal Revenue Code unless otherwise noted.

Purpose of Form

A person who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) to report, for example, income paid to you, real estate transactions, mortgage interest you paid, acquisition or abandonment of secured property, cancellation of debt, or contributions you made to an IRA.

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN to the person requesting it (the requester) and, when applicable, to:

1. Certify that the TIN you are giving is correct (or you are waiting for a number to be issued),
2. Certify that you are not subject to backup withholding, or
3. Claim exemption from backup withholding if you are a U.S. exempt payee. If applicable, you are also certifying that as a U.S. person, your allocable share of any partnership income from a U.S. trade or business is not subject to the withholding tax on foreign partners' share of effectively connected income.

Note. If a requester gives you a form other than Form W-9 to request your TIN, you must use the requester's form if it is substantially similar to this Form W-9.

Definition of a U.S. person. For federal tax purposes, you are considered a U.S. person if you are:

- An individual who is a U.S. citizen or U.S. resident alien,
- A partnership, corporation, company, or association created or organized in the United States or under the laws of the United States,
- An estate (other than a foreign estate), or
- A domestic trust (as defined in Regulations section 301.7701-7).

Special rules for partnerships. Partnerships that conduct a trade or business in the United States are generally required to pay a withholding tax on any foreign partners' share of income from such business. Further, in certain cases where a Form W-9 has not been received, a partnership is required to presume that a partner is a foreign person, and pay the withholding tax. Therefore, if you are a U.S. person that is a partner in a partnership conducting a trade or business in the United States, provide Form W-9 to the partnership to establish your U.S. status and avoid withholding on your share of partnership income.

The person who gives Form W-9 to the partnership for purposes of establishing its U.S. status and avoiding withholding on its allocable share of net income from the partnership conducting a trade or business in the United States is in the following cases:

- The U.S. owner of a disregarded entity and not the entity,
