AGREEMENT

1.1 Exhibitor/owner agrees to abide by the rules and regulations of 4-H, AKC and San Antonio Livestock Exposition, Inc. and any other rules and regulations appearing in the premium for this event.

1.2 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.3 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to: the condition of the property, isles, lighting, security measures (or lack thereof), show rings, crating area, parking areas and the presence of unfamiliar animals and people. Exhibitor and owner assume the risk of any harm arising from these.

1.4 RELEASE AND INDEMNIFICATION: EXHIBITOR/OWNER HEREBY INDEMNIFIES, RELEASES AND HOLDS HARMLESS, GUADALUPE COUNTY 4-H, TEXAS K9 ALL STARS, AFFILIATE/LICENSEE CLUB SCHERTZ 4-H GUAD SQUAD, SAN ANTONIO LIVESTOCK EXPOSITION, INC. AND EACH OF THEIR RESPECTIVE DIRECTORS, OFFICERS, MANAGERS, EMPLOYEES, OWNERS, PARTNERS, AGENTS AND ASSIGNS (COLLECTIVELY, THE "RELEASED PARTIES") FROM AND AGAINST ANY DEMANDS, CAUSES OF ACTION, PROCEEDINGS, FINES, PENALTIES, LOSSES, LIABILITIES, DAMAGES, COSTS, EXPENSES (INCLUDING REASONABLE ATTORNEYS' FEES) OR CLAIMS FOR INJURIES TO PERSONS, INCLUDING DEATH, OR DAMAGE TO PROPERTY (COLLECTIVELY, "LIABILITIES") TO WHICH THE RELEASED PARTIES, OR ANY OF THEM, MAY BECOME SUBJECT, WHICH ARISE FROM OR IN CONNECTION WITH, OR IN ANY WAY RELATE TO THE EVENT OR THE EVENT PREMESIS INCLUDING, BUT NOT LIMITED TO THOSE INVOLVING THE ENTERED DOG. EXHIBITOR/OWNER HEREBY ACKNOWLEDGES AND AGREES THAT THE FOREGOING INDEMNITY AND RELEASE PROVISIONS INCLUDE INDEMNIFICATION AND RELEASE BY EXHIBITOR/OWNER FROM AND AGAINST THE RELEASED PARTIES' OWN NEGLIGENCE.

The foregoing indemnification and release provisions are intended to have the broadest possible legal effect and to release and indemnify the Released Parties against all Liabilities of every sort, known or unknown, foreseeable or unforeseeable, future or contingent.
