The competition will take place at the San Antonio Stock Show & Rodeo on the Salado at 2201 Pace Picante Place, San Antonio, TX 78219. When using GPS to locate the property, please use 1723 Creekview Drive, San Antonio, Texas 78219. One complimentary parking pass will be provided to each contestant. Parking will be located at the AT&T Center and shuttles will be available to the competition site. AT&T Center parking is located through Lot 6, Gate G off of AT&T Parkway. Upon completion of a contestant's registration, detailed instructions for animal delivery to the grounds will be provided. Additionally, each registered contestant will receive one complimentary grounds admission for themselves and one for a parent or guardian.

DOGS ELIGIBLE TO ENTER

This Trial is open to all dogs 18 months of age or older that are registered on Texas 4-H Connect, except bitches in season, aggressive dogs, or blind or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance.

OBSTACLES & EXHIBITOR INFORMATION

- Obstacles shall meet the specifications for obstacles in the current edition of the AKC Regulations for Agility Trials.
- All exhibitors and/or handlers are responsible for entering their dogs in the proper height classification. In the Standard classes dogs may run in a higher height division, but not a lower height division than their measured height division.
- If an email address is provided, email notification of your entry status will be sent prior to closing as entries are processed.
- If an email address is provided, confirmations and judging schedules will be sent via email after closing.
- Entry Agreement must be attached to entry form for the entry to be valid. Entries received without the entry agreement are not valid and will be returned.

MEASURING AND HEIGHT CARD INFORMATION

All dogs will need to be measured unless the dog has an official jump height card from an agility venue such as AKC, ASCA, NADAC, etc.

AKC JUMP HEIGHTS

Dogs 11 inches & under	8" Jump	4" Jump
Dogs 14 inches & under	12" Jump	8" Jump
Dogs 18 inches & under	16" Jump	12" Jump

TRIAL HOURS AND CRATING

- Trial hours will be 8:00 a.m. to 30 minutes after last run. The crating space is limited. Crating will be under cover in a tent. Participants will be allowed to stay for the Cook-Off Festival.
- Un-entered dogs will be allowed only if you are able to stack their crate on top of an entered dog's crate and owned by the exhibitor.
- No other dogs are allowed on the Trial site.
- No X pens or mats will be allowed.
- Crating spaces will be designated.
- The facility is not available to us until Saturday morning.
- **MUST cover crate if requested by member of Trial Committee.**

CONCESSIONS & FUNDRAISER

Bottled water will be provided for contestants and canines. Food will be available for purchase in the food court and concession areas located on site. The Schertz 4-H Guad Squad will be selling homemade dog toys within the Trial area. Please come prepared if you are interested in supporting the organization.

NOTICE TO EXHIBITORS

- **Entries not on official Entry Forms or Entry Forms without Agreement and Rules attached are NOT ACCEPTABLE.**
- Unsigned Entry Forms cannot be accepted or entries which specify any conditions as to its acceptance. Telegraph, telephone and fax entries cannot be accepted.
- Emailed entries will be accepted provided payment follows before the show.
- The safety of the dogs is our primary concern. By entering this Trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- The San Antonio Livestock Exposition, Inc. d/b/a San Antonio Stock Show & Rodeo will act as host for the event during the 2017 Bar-B-Que Cook-Off and Festival.
- Entry fee will not be refunded in the event that the dog is absent, disqualified, excused or barred from competition by action of the Trial Committee. No entry fee will be returned if the Trial cannot open or be completed by reason of civil disturbance, fire and act of God, public emergency, act of a public enemy or any other cause beyond the control of the organizing committee.
- Trial will be run under light rain and in the cold weather. Prepare appropriately.
- Returned checks do not constitute a valid entry. A \$25.00 service fee will be added for all returned checks.
- No refund for duplicate entries. Care will be taken to find duplicates; however, if an entry has been processed no refund will be made.
- Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in the event of such errors or cancellation of entries after published closing date. PLEASE PRINT OR TYPE CLEARLY.
- All dogs present must be on leash or confined to crates when not being judged except when in the designated warm-up area.

- It is expressly understood that the exhibitors and parents alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the Trial site. In such a case, no refund of any entry fees will be made. This Trial will be held in conjunction with the Bar-B-Que Cook-Off and Festival. Please keep dogs away from BBQ area.
- Bitches in season are not permitted in the Trial, and Schertz 4-H Guad Squad will refund all but \$14.00 per day of entry fees for bitches in season. The Trial Secretary must receive written veterinary certification no later than 30 minutes prior to the start of the 1st class of the day. Refunds will be mailed after the close of the event.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. Judge need not wait for any dog holding up a class. 4-H and the Trial Secretary have no obligation or responsibility for providing service through a public-address system or stewards for the purposes of calling or locating dogs that are not brought into the ring when required.
- Schertz 4-H Guad Squad assumes no responsibility for anything lost or stolen.
- Exhibitors are responsible for picking up after their own dogs. Failure to do so could result in being excused from the Trial.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.
- No dogs may be left at the Trial site overnight.

Schertz 4-H Guad Squad and Texas K9 All Stars reserve the right to decline entries for cause and may remove any dog on account of aggression, disease, injury or illness that may affect the dog's physical or mental performance. No one shall have any recourse or claim against Schertz 4-H Guad Squad and Texas K9 All Stars or the San Antonio Livestock Exposition, Inc. or any official thereof."
