



HENDERSON COUNTY 4-H WHIZ BANG BUCKLE SHOOT OUT!!!

March 15, 2014 at Rose City Flying Clays in Tyler, TX. This shoot is limited to the first 100 4-H shooters for American Skeet, Trap, Whiz-Bang and Sporting Clays. Registration will start at 8:00 AM, Safety at 8:30 AM and shooting will start at 9:00 AM.

Deadline for registration: March 5, 2014. Registrations received after March 5, 2014 will be charged a late fee in the amount of \$25.00 if space is available.

Award Presentation: HOA Champion and Runner Up Belt Buckles will be presented for the following classes: Junior, Intermediate, Senior I and Senior II and HOA Champion-Ladies. To qualify for HOA the shooter must participate in all four disciplines. All disciplines will place 1st – 5th places.

Payment: Payment by cashier's check, money order or personal check made payable to Henderson County 4-H Shotgun Sports. When paying by personal check, any returned check will result in cancellation of the entry/entries that the check was paying for. To re-enter you must pay a \$30.00 return check fee. This option will only be available if there are still open slots.

Refund Policy: Refunds minus a \$25.00 registration fee will be made to any shooter who cancels before March 3, 2014. NO refund will be made for cancellations or no shows after March 3, 2014. All requests for refunds must be received in writing by one of the following methods, e-mail or U.S. Mail at the address provided below. All refunds will be processed and mailed after the tournament is completed.

Tie Breakers: Any ties in the Sporting Clays event will be decided by a Station Tie Breaker. All other events will have the tie settled by a shoot off.

Parent/Coach on fields: No coaching will be allowed while the youth shooter is on the field or in the cage during events. For safety reasons, parents will not be allowed on the skeet or trap fields. Failure to adhere to this rule will result in the disqualification of the youth shooter affiliated with that adult for that event. On the Whiz Bang and Sporting Clay fields spectators, parents or coaches will maintain a respectable distance from the shooting cages to allow the referee room to officiate the match. At no time may the parent, coach or spectator interfere with

the duties of the referee. Failure to respect this will result in the disqualification of the youth shooter affiliated with that spectator, parent or coach. Continued failure to adhere to these rules will result in the expulsion of the parent, coach or spectator.

Shooting Carts: Shooting carts may be used at this complex. Anyone driving recklessly in a shooting cart will be asked to park the cart until the end of the shoot. No exceptions.

Novice Class: For this tournament, a Novice Class shooter will be any shooter who is in their first year of 4-H shooting (2014). Novice classes will be Junior (age 13 and under) and Senior (age 14 and over). **Events for Novice shooters will be Skeet and Trap ONLY.**

4-H Enrollment: This is a 4-H event; therefore all entrants must be members of a Texas 4-H Club.

Protest Procedure: Protest should be initiated immediately to the field referee and can only be initiated by the shooter. No protest will be accepted from parents and/or coaches.

Code of Conduct: The current 4-H Code of Conduct will be enforced both on and off the field during this event. Shooters, volunteers, family members or observers may be expelled from the event, match or grounds for failure to comply. Shoot management reserves the right to refuse future registration to any shooter who does not comply with the current 4-H Code of Conduct.

Shooting Agreement & Waiver of Liability: Please fill out and return the Shooting agreement and Waiver of Liability form and return with the registration form. Each shooter (youth and adult) will need to sign the attached waiver. **Your registration will not be processed unless all forms are returned together.**

Directions to Rose City Flying Clays: From junction of US 69 N on Tyler Loop 323.

1. East on Loop 323 take the 2nd left past the railroad tracks. There will be a large Rose City Flying Clay's sign next to Texas College Road.
2. Turn north on Texas College Road and go approx. 1 mile past a double "S" curve sign and on approach to the 2nd double "S" curve sign. Another Rose City Flying Clay's sign is on the right and marks the gate and driveway into the clubhouse.
