2018 NCHA Intercollegiate Judging Contest Guidelines

Written Exam: (150 pts)

- Closed rulebook test will be taken from Judges and Judging Rules sections of the rulebook (2018 rule book pages 100 – 150)
- Exam will be multiple choice and answers submitted on a scantron

Penalty Clip Test: (150 pts)

- Short video clips of runs will be shown, and contestants will have 30 seconds to designate what penalty or penalties, if any occurred during the video clip.
- Runs with no penalties should be marked “NP”
- There will be a multiple choice selection for each clip, answers will be submitted on a scantron

Scoring two sets of 10 runs:

- NCHA official judge’s cards will be used for scoring
- Contestants will act as their own scribe
- Contestants should place the draw number (1 thorough 10) in the “horse” column, not the exhibitors back number
- Run content will not be evaluated when determining the contestant points, except that if the run content is left blank the contestant will receive -50 points on the score deviation.

Score Deviations: (100 pts / set of 10)

- Contestants receive or lose points based on how close each of their scores are to the official score.
- Using the calculated average from the officials average (i.e. 70 for a 210; a 70 or $70\frac{1}{2}$ for a $210\frac{1}{2}$).

Deviation from official score	Contestant score (+ or – from 100)
0	+1
-1/2 to +1/2	0
-1 to +1	-1
-1 ½ to +1 ½	-2
-2 to +2	-3
Etc.	Etc.

- Add or subtract points from a possible of 100.
- In cases of an official Zero Score that is missed by the contestant, or the contestant Zero Scores a horse that the officials did not Zero Score, the deviation will be -50 points for that horse.

Placing Cuts: (250 pts / set of 10)

- Using the calculated average from the officials average, cuts will be assigned as follows:

Spread for officials average	Cut
0	0
½ - 1 ½	1
2 - 3	2
3 ½ - 4 ½	3
5 - 6	4
6 ½ - 9	5
9 ½ - 15	6
>15	7
