Order Deadline: Wednesday, September 20th to the Travis County Extension Office by 5pm.

Please note: Birds must be ordered in multiples of 25, with a minimum order of 25, and a maximum of 75 per exhibitor (or a maximum of 75 per family if sharing the birds with siblings in the same household). Individuals/Families may submit one order for the Houston Livestock Show and Rodeo (HLSR) hatch date, the Rodeo Austin (RA) hatch date and one order for the San Antonio Stock Show and Rodeo (SASSR) Hatch Date. We recommend ordering more than the minimum and culling at regular intervals during the growing process. **Please remember that ordering chicks does NOT enter you in any Major or County Shows. You will need to complete one entry form per child for each show in addition to ordering chicks.**

This order is due in the Extension office by Wednesday, September 20, 2023. **Late Orders will not be accepted.** Payment is due at the time of submission.

Birds should arrive around the first week of January for San Antonio (SASSR)

Birds should arrive around the fourth week of January for Houston (HLSR)/Rodeo Austin (RA)
